**A RESOLUTION RATIFYING AND CONFIRMING THE CITY OF SANIBEL'S EXISTING CODE ENFORCEMENT OFFICERS AND APPOINTING CERTAIN CURRENT EMPLOYEES AS ADDITIONAL CODE ENFORCEMENT OFFICERS FOR CODE ENFORCEMENT OF CERTAIN ENVIRONMENTAL REGULATIONS PURSUANT TO CHAPTER 162, FLORIDA STATUTES, AND CHAPTER 2, ADMINISTRATION, ARTICLE VII, CODE ENFORCEMENT, OF THE SANIBEL CODE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Chapter 162, Florida Statutes, and Chapter 2, Article VII of the Sanibel Code, set forth the provisions for an alternative code enforcement system which may be used by the City of Sanibel; and

**WHEREAS**, the City of Sanibel currently has two (2) persons designated as full-time Code Enforcement Officers; and

**WHEREAS**, in order to enhance the enforcement of the City's Environmental Protection Laws relating to the City's fertilizer and exotic vegetation legislation, the City Council finds it necessary and appropriate to designate the current Natural Resources Staff Members as additional Code Enforcement Officers to enforce such laws;

**NOW THEREFORE BE IT RESOLVED** by the City Council of the City of Sanibel, Florida;

**SECTION 1.** The City Council hereby designates current Natural Resources Staff Members, Dr. Rob Loflin, James Evans, and Holly Downing, as Code Enforcement Officers for purposes of alternate code enforcement for all environmental regulations relating to exotic vegetation and fertilizer, in accordance with Chapter 162, Florida Statutes, and Chapter 2, Article VII, of the Sanibel Code.

**SECTION 2.** The City Council hereby ratifies and confirms that Ray Hendzel and Terri Cummins serve as the City of Sanibel's two (2) full-time Code Enforcement Officers for all Sanibel Codes and Ordinances.

**SECTION 3.** Effective Date.

This resolution shall take effect immediately upon adoption.
